The new committee consists of:



It was also suggested that members encourage residents from the lower Maldon Road area to form their own association as many of them share our open space concerns.



END OF THE ROAD FOR PMS?

"...all local authority schemes that have not reached financial close will not go ahead..."

The recent announcement by the Education Secretary, Michael Gove that all school spending projects not already funded are to be scrapped should mean the end of the deeply unpopular Philip Morant School access road, as most of the spurious justification for this colossal waste of money has evaporated. The promised £130m has proved to be exactly the mirage we always said it would be, but it now remains to be seen whether a new justification will be offered by the school and Essex County Council. PMS have made it plain that they intend to keep pushing for a road, claiming that 'nothing has



changed' in the 11 years since planning permission was first granted, but ECC, who had previously hinted that they would be prepared to fund the road separately, without the anticipated grant, have put the schools re-organisation as a whole on hold for at least a year. In any case, Colchester Borough Council have rescinded their decision to release the land for the road as their conditions can no longer be met.

Sanity Returns?

The document issued by the DFES shows quite clearly that the Philip Morant and Thomas Lord Audley rebuilds are stopped for the foreseeable future. Sir Charles Lucas is up for discussion, but it's hard to see this happening without the rest of the Colchester schools reorganisation. We'll have to wait and

Philip Morant School continues to ignore local community in refusal to give up agreed land


In their latest snub to the local community, the Board of Governors of Philip Morant School have flatly refused to agree to the enlargement of the Irvine Road Field as compensation for the massive damage their proposed new access road would have caused.

The terms of the Colchester Borough Council Cabinet's provisional approval to release the land necessary for the road included a requirement to replace the land taken up by the road, and to work with local residents to ensure that damage and loss of amenity was kept to a minimum.

After six months of cynical procrastination and

much empty talk about 'working with the community to 'increase open space' the school finally admitted that they had no intention of increasing the public open space in the area and reluctantly agreed to release the bare minimum required.

IRARA had been under the impression that they had agreed to enlarge the Irvine Road Field by just over 8m on the Northern Boundary, but, true to form, they reneged on even that puny commitment and ended up trying to offload the inaccessible, overgrown triangle in the Eastern corner of their field. The reason given was that the $\Rightarrow \Rightarrow$

governors felt that their playing field would be 'even more separated' from the school grounds, a transparently ridiculous excuse and the latest in a long line of attempts to conceal the school's true long-term ambitions, to develop their playing field.

Shady Lane a cycle path?

Supporting our suspicions are the school's increasingly obvious attempts to force local residents to agree to turn Shady Lane into a tarmac cycle path, which would require the removal of all the hedging along the narrowest part and the cutting back of much of the hedgerow along the lane next to the field.

This is obviously part of a long term plan to close off the permissive footpath between the schools and join the PMS playing field to the rest of the school, despite the fact that a very large number of local schoolchildren depend on that path for safe access to school.

Fortunately, much of this has been rendered academic by the recent budget cuts,





but we can expect this pressure to increase in the future, with or without the road.

The good news is that ECC promised to hand over the Irvine Road Field to be kept in trust as permanent public open space, rgardless of the outcome of these talks. We shall be pushing to ensure they keep that promise.

It's good to talk

Another issue raised at the IRARA AGM was the possibility of increasing communication and distribution of notices and newsletters via email.

We have polled members in the past in an attempt to find out how many of you are in the habit of communicating electronically, and were amazed when only 9 of those who responded said they were interested in using the internet. That was a few years ago, however, and perhaps it's time to look again at what the web can do for the association.

Newsletters

Newsletters have always been available on the IRARA website to read or download and it has been suggested that we circulate electronic versions to members as well as posting them through letterboxes.

If you want to receive the newsletter via email in future, just use the contact form on the website and let us have your email address. Obviously your details will not be passed on to anyone else.

Email is also an excellent way of disseminating the IRARA point of view and members are very welcome to forward newsletters to friends and colleagues. Current newsletters will also be posted on the new noticeboard by the path to the allotments.
